BACKGROUND

The collective agreement between the board and CUPE 8443 expired on August 31, 2025. The parties engaged in interest-based negotiations which commenced in May of 2025 and continued during the 2025-26 school year until the tentative agreement was reached on June 19, 2026.

CURRENT STATUS

The bargaining team has reached a tentative three-year agreement with CUPE 8443, expiring August 31, 2028.

CUPE Local 8443 intends to take the tentative agreement to its members with ratification meetings scheduled for Thursday, June 25 and Saturday, June 27, 2026.
